Response: Our Parent Resource area will be set-up in our media center. Our strategy is to inform parents to the best of our ability as to our programs, the needs of the children and opportunities here at the school. Information will be posted on the school's marquee, on Edline, on the parent section of the school's website by the School Choice Coordinator in a consistent manner, providing updates weekly, or earlier if circumstance warrants. The principals' secretary will be in charge of drafting and distribution of the Principal's newsletter, in coordination with the principal and assistant principal. We will work through the SAC to arrange times that our media center will be open to offer access to the Parent Resource Center. If possible, we will work with our Parent Volunteers to arrange for supervision, maintenance of the resources, sign-in sheets and follow-up evaluations/suggestions for improvement of the resource area. In addition, our Senior volunteers received training and work in classrooms as listeners and/or readers to small groups of students.

Response: The Title I Annual Meeting (September 14, 2016) was used to discuss with parents the requirements of BRES being a Title I-A school. Parents were able to complete post evaluations to provide input.

Curriculum events are held throughout the year to provide parents with current information on:

student assessments in Reading, Math and Science; proficiency levels, and pupil progression, including FSA, Common Core aligned and NGSS Standards.

SAC meetings are held monthly for parents to formulate suggestions and to participate in educational decisions. Including, remediation, enrichment activities; family-fun activities; fund raising; and staff appreciation.

Teachers use Student Agendas for daily communication with parents and students. Along with emails, in-person conferences and phone calls.

The Parent Link voice call out system is used as needed to communicate timely information to parents and now include the ability to send text messages to parents, for quicker more clear and efficient communication.

Parent-Teacher conferences are held as needed to communicate classroom expecations, student academic performance and parental concerns, conferences are held a minimum of three times a year.

Edline is used to keep parents informed about specific classroom news, curriculum, instructional materials and home-school resources.

Response: For our hearing-impaired parents we send communications via text-messages. All levels of communication will be sent out in the languages applicable to BRES, including translations by our Spanish CLF and Creole CLF, as well as any documents made available through the district in Portuguese. We also provide choice seating during our parent events and elevator access for our wheelchair bound parents.

We have a language facilitator for our Spanish-speaking parents. In addition we have a Portuguese speaking staff member on campus to provide translations as needed. They will participate in IEP/LEP meetings, conferences and other school events, as well as parent needs as they arise throughout the day, such as making contact regarding a sick child.

Boca Raton Elementary will use multiple approaches to contact parents who speak a language

other than English. We provide print communication translated into both Spanish and Creole, trying to ensure that information is available to parents considering fluctuating student population. Boca Raton Elementary will ensure that If other languages are needed, the school will send the material to the Title I office for the Palm Beach County School District will be contacted to provide the translations. We have designated a parent liaison to help be a further bridge between school and parents.
