SCHOOL IMPROVEMENT PLAN END OF YEAR:

The EESAC discussed SIP EOY and made the following recommendations:

The school's Community Involvement Specialist (CIS) Miriam SanJorge provided the EESAC with an overview of our current Parent Involvement Plan (PIP) and School-Parent Compact. She asked the EESAC to provide recommendations and feedback regarding how to continue to support parental involvement during the 2016-2017 school year.

Recommendations included:

- 1. provide parent workshops (AM hours)
- 2. send home monthly school calendars
- 3. promote parental involvement through the school's PTA

FSA RESULTS THIRD GRADE

Ms. Mason and Ms. Companioni provided the EESAC with an overview of the newly released third grade ELA data. Results indicate that 44 out of 88 students tested scored at Level 1 and 2, a 4 percentage point decrease from 2015. There was a slight increase in the percent of students meeting high standards in Reading, from 48% in 2015 to 53% in 2016. Dr. Marban shared that the weakest category remained Integration of Knowledge and Ideas whereas students scored at an average of 40% mastery. Goals for the upcoming school year include a schoolwide emphasis on this standard through implementation of literary activities during school and beyond the school day.

PTA:

Ms. Coles provided the EESAC with an overview of the PTA activities held throughout the school year and preliminary plans for the upcoming school year. She thanked administrators, teachers and parents for their continued support.

GREETINGS FROM THE ADMINISTRATION:

Ms. Barreira welcomed the EESAC and introduced Dr. Marban who was recently appointed as interim assistant principal until Ms. Companioni returns from an interim principalship in December. She addressed concerns regarding low enrollment and surplus teachers; shared that the school was in the process for applying for the STEM program; and, informed parents of upcoming upcoming SAT and FSA parent meetings in October.
