



Response: Lake Region High School has a number of parental support groups who encourage and welcome parental involvement. Band boosters, Drama club parents, sports boosters, FFA and academy parents participate in various events and activities throughout the year. In addition, many of these organizations provide/require tutoring services in order to help students maintain academic eligibility. Our monthly newsletter informs parents of upcoming events that they may participate in, deadline dates for scholarships & tests, upcoming student meetings, Yearbook, Parent portal access, promotes our website and mobile app. The school website also includes similar information that the parents can access, daily announcements that the students hear in class, Guidance page which informs parents and students about graduation requirements, scholarships etc., Club pages, sports schedules and the Principals. Parents and students can sign up in Remind 101 to get messages from their teachers about upcoming tests, due dates or general information.

In order to provide parents with timely information about programs, curriculum, assessments, and achievement expectations, Lake Region H.S. will provide a variety of means of communication. Parents will be notified using the school website, mobile app, Remind 101, flyers, meetings, curriculum documents, progress reports, standardized assessment reports, emails, and individual parent conferences. Progress monitoring exams are given several times a year in Math, Reading/English and Writing through a District implemented program. One of our focuses is the use of formative assessments. Florida State Standards testing (EOC's/EOY's) is conducted throughout the year as designated by the District testing dept. In addition, parents can monitor grades using the Parent Portal system by going to our school website www.lakeregionthunder.com, and by requesting parent/teacher conferences contacting the guidance department/teachers via phone calls or emails. For parents who do not have access to the internet, the school will provide interim reports the weeks of Sept. 12, 2016; Nov. 28th, 2016; Feb. 13th, 2017; May 1st, 2017, and report cards the weeks of Oct. 31st, 2016; Jan. 23rd, 2017; Apr. 10th, 2016; after school finishes on June 5th, 2017. Teachers routinely contact parents on an individual basis to communicate their child's progress. All notes and pertinent communication sent home is available in Spanish and Creole for our non-

English-speaking parents. A translator is available to translate notes and is present for individual parent meetings as needed.

Parents and the community are strongly encouraged to attend and participate in the School Advisory Council (SAC) meetings. Through their participation, we will be able to work closely to ensure success for students, the community and our school. Meetings will be held throughout the year at various times. Parents will be informed of meetings via one or more of the following methods: flyers, Remind 101, or website. During these meetings, parents receive information on school discipline, policies, grades, Annual Measureable Objectives (AMO), Title 1, Parent University, parent involvement and school activities. A school survey will be provided and collected at every parent activity focused on building capacity. In addition, parents are encouraged to contact the school with concerns or to share suggestions.

During the Annual meeting translation will be provided by a full-time ELL staff member in both Spanish and Creole.

The District has assigned Lake Region HS a Student Success Migrant Coach who is available to meet with parents and students.

Parents are given the opportunity to get involved in the educational decision making process of their child's education vby taking part in the school's School Advisory Council (SAC).

All parental information sent home via flyers and website will consist of English and Non-English speaking languages to reach all parents. We will provided child care as needed.
