Response: Central Avenue Elementary encourages and supports parents by engaging them to attend various events throughout the school year such as Literacy and Math Family nights. CAE will also coordinate with the Parental Involvement Act and provide time and space for the Parent Resource Centers to be available for all parents on campus. The Title I Mobile Parent Center provides resources to all the parents of CAE. The Title I Mobile Lab is available on the first and third Tuesday of the Month from 12:30-3:30. Parents can either view materials, borrow up to three supplemental educational items for 2 weeks and return them to the school.

Parents are invited in throughout the year for computer assistance with volunteer applications.

Central will also be providing parents will training and overview of the new Florida Standards Assessments. Parents and students will have the opportunity to see sample test items and take practice tests. Coaches and teachers are available to assist any parents with curriculum questions and tips to help their child be successful. This is done for Language Arts, Math and Science.

The leadership team completes the in-house Title I check list prior to each family event. This ensures that proper advertisement and communication is fulfilled. It also ensures that flyers and advertisements are completed in a timely manner. Events are announced through flyers, iris calls, school website, newsletters and large and small marquis.

During registration all parents will be encouraged to attend our Meet & Greet event scheduled for August 8 from 3:00 - 6:00 pm. We will also be holding an Open House in September of 2016. At that time parents will be able to visit classrooms and speak to the teachers and will be given specific information on the Florida Standards curriculum, assessment plans, and information on how the parents can help their children at home. Parents will also be presented with a Stop Bullying Now presentation. Teachers will collect Sign In sheets and they will be turned into the CAE Parent Liaison, so they can be kept for attendance documentation.

During weekly department and grade level meetings, faculty and staff are directed to continue updating all stakeholders and complete proper forms when scheduling events or activities.

Title I booklets and District PIP were provided to the parents in the first day packets. Every new student that is registered will receive a copy. A Title I menu to access links to Title I is available through the school's website.

CAE will hold a general meeting for parents during the Title I Annual Meeting in October 2016. The meeting will be held both during the day and at night to accommodate parent schedules. During that meeting parents will be informed about the Title I Program that CAE provides. Curriculum and the academic assessments will be explained. Parents will also receive information on how to schedule parent/teacher conferences and opportunities to participate in volunteer activities within the school.

Curriculum being used at the school is addressed at the school SAC and PTO meetings. Also, grade levels are reviewing the Florida Standards curriculum at the Open House with parents. Technology links are available directly on the CAE website for parent access. Parent Portal, also on our website, provides parents with a direct link to their child's current grades.

Any parent can request a conference with the teacher and must give at least a 24 hour preparation for the teacher. Both in person and phone conferences are available. Parents may contact teachers via the agenda or their school district email address to discuss work and behaviors.

SAC Committee is for both parents and teachers to work together in helping evaluate the School Improvement Plan and to help generate other ideas for programs to help to achieve our school plan. It also allows monthly updates on the administrative side of school issues from the curriculum to testing to behaviors and even great achievements by students and staff. All parents are invited to join the SAC committee or just join a meeting. All new SAC members are voted in by current SAC members.

ESE, ESOL, MTSS and 504 parent meetings are held at least annually in order to update and document student learning goals and gains in their specified work area.

The school has several marquees in the front to post dates and times of important events.

CAE provides agendas for all students and we utilize student agendas in grades K - 5 for daily parent communication. The Title I Compact as well as a calendar of our yearlong parental involvement activities are included in the parent handbook that is located in the front of the student agendas. Labels are used for announcements, and parents and teacher have an effective, personal way to communicate. We also utilize an out dial feature on our phone system IRIS to call students' homes to disseminate information to parents in English and in Spanish regarding important announcements and events. Regular emails are sent to staff to ensure all information is sent to students on a regular basis.

Parents are also provided regular reports of academic progress through report cards, progress reports, and completed assignments. Invitations to attend school meetings and conferences go home in the students' agendas and are provided in both languages.
