Parent newsletters are sent home via backpack with progress reports and report cards each 9 weeks. These newsletters include dates for upcoming events and meetings. Administration further advertises all events in multiple formats including flyers, marquee, school website and Connect Orange

messages. Documentation of parent notification is maintained in the Title I contact's office.
