Parents are welcome to check out materials and participate in activities that will teach them how to better assist their children at home. The Parent Academy is a Miami-Dade County Public School initiative that provides free skill building classes for parents, and free educational events and activities for families. Oak Grove Elementary School will host enrichment workshops provided by the Parent Academy monthly for parents developed around the five subject area standard: Arts & Culture, Health and Welfare, Help Your Child Learn, Parenting Skills, and Personal Growth. During the Annual Title I Meeting parents will provided information about Title I, No Child Left Behind (NCLB) Parent-School Compact and Parental Involvement Plan.
