RESPONSE:

Palm View involves parents and families in an organized, ongoing and timely manner in planning, making decisions about, reviewing and improving Title I programs, parent involvement programs, the School Improvement Plan, the school budget and the Parent-School Compact.

Parents, families, and community members are involved in the annual revisions of our Parent Compact Agreement. Each year at our spring SAC meeting, we conduct an activity engaging parents in reflecting on what they believe their priorities as parents should be in supporting the school, how teachers can support them as parents and their children as students, and how the leadership team at Palm View can involve them more in decisions that affect them and their children. At Back-to-School Night, teachers discuss the Compact with families, who are asked to sign it.

In August, our SAC parents discuss and determine through a voting process how our SAC/SIP funds should be expended to have the broadest impact on the most students in support of increasing student achievement. SAC parents are invited to attend the district SAC meetings. Eight Palm View parents attended one of the district SAC meetings in 2017-18, when most schools had one representative.

In September, we meet with parents to explain what Title I is, the impact it has on their children and our school, and how they can be involved in helping us make decisions about priorities for our Title I budget.

After Winter Break each school year, we begin discussions with parents at our SAC meetings about what our priorities should be for our School Improvement Plan. We ask for at least one SAC parent to join our SIP writing team. When we receive our projected Title I budget, we share that with our SAC parents and facilitate a discussion about how the monies can be spent and solicit their ideas, focusing on shared values and priorities.

Once the Title I budget is drafted, we share it with SAC and request further input. In our planning, we emphasize that Title I funds are supplementary, and that they should be utilized primarily to support our SIP initiatives.

1	21 st Century Grant Program	The 21 st Century Community Learning Center is a grant-funded after-school program that provides homework assistance, enrichment, and academics. Its purpose is to improve reading, math and science performance of our students. The program serves approximately 90 K-5 Palm View Students from dismissal until 6:00 P.M. and is staffed by highly qualified Palm View Teachers and paraprofessionals. Students receive an afternoon "heavy" snack provided through Food Service. Our 21 st Century Program Coordinator organizes monthly family education and involvement activities. For example, in September, Kim Graves from Teacher Made Materials organized learning centers for parents and their children to educate the parents about how to support their children in improving their academic achievement in school, and distributed parent education materials in English and Spanish. In October, the parent event was "Spooky STEM Night."
2	Family STEM Night	Palm View utilized Title I funds to contract with the Orlando Science Center on October 5, to set up 15 hands-on Science, Technology, Engineering and Math stations, which were manned by our teachers, staff, and community volunteers. Over 169 parents and children participated together in the various STEM activities.
3	Write a Play	Florida Studio Theatre has found a sponsor for our school so that our fourth grade classes can participate in the Write a Play Program for free, including free theatre performances (admission and transportation provided).

Science Science through Circus Arts The Circus Arts Conservatory has provided a free assembly for grade students and a free curriculum for the teachers to utilize Florida Science Power Standards through the Circus Arts. At parent events, the coalition distributes free books to Palm View students and younger siblings and provides educational materials to parents.

RESPONSE:

The principal sent a letter home in both English and Spanish notifying parents/guardians of their right to request information on the professional qualifications of their child's teacher and paraprofessionals, and discussed the rights with parents at the Title I Parent Meeting in September. Also at the Title I Parent Meeting, the principal talked with parents about the individual progress reports on their child's progress on state assessments. The score reports were sent home with students. Reports were mailed to the parents of last year's 5th graders. On September 7, the Principal sent home a letter in English and Spanish notifying parents about teachers who are out-of-field in ESOL. All of Palm View's teachers are highly qualified. No students have been taught for four or more consecutive weeks by a teacher who is not highly qualified during the 2017-18 school year.

RESPONSE: Palm View publishes an August newsletter and a parent handbook in which the information about Title I is published. The August newsletter is mailed home to parents and the parent handbook is distributed at Back-to-School Night and distributed to parents when they enroll their children. The article defines Title I; invites parents to our annual Title I meeting; explains the budgeting process for Title I funds and how they will be expended for this school year, including how the budget supports the School Improvement Plan; encourages parents to collaborate with Palm View; and explains the importance of completing the annual district Title I survey. The article also includes the following paragraph:

Child Care, Translation Services, Transportation

Palm View strives to schedule parent-teacher conferences, meetings, and family activities at times that are most convenient for parents. However, sometimes parents do not have transportation or cannot attend because of child care needs or because they do not speak English. If any of these concerns are issues for you, please contact our front desk receptionist. Title I funds may be utilized to provide transportation, child care, and/or translation services for parents.

During the past five years, Palm View has attempted to schedule parent meetings at different times of the day and on various days of the week. Any meetings scheduled other than Thursday evenings have been very poorly attended. Therefore, parent meetings are generally scheduled only on Thursday evenings, either at 6:00 or 6:30, to meet the needs of our parents. However, two events scheduled before school have been so heavily attended that the school is challenged with handling the crowds – Dads and Donuts in September (Dads Take

Your Child to School Day) and Moms and Muffins in May. Last May, because the School Advisory Council has been pushing for uniforms for the past five years, but cannot get enough parents to submit their votes, the school created a display of actual uniforms and provided ballots at Moms and Muffins. Then ballots were mailed home to parents who did not attend the event. The push was successful – Palm View will have uniforms for the first time, starting in 2018-19. At Dads and Donuts in September 2017, the meeting focused on recognizing veterans and discussing the importance of Dads' involvement in their child's education, and especially on insuring that their children are on time and at school every day.

Therefore, the training provided will take faculty and staff to the next level through collaboration about how to build stronger ties through more frequent and ongoing communication, especially publishing weekly or monthly newsletters about the curriculum and offering activities that families can conduct at home with their children to support achievement in reading, writing, math and science. This practice is not consistent across grade as evidenced through documentation gathered through the district teacher evaluation process for Domain 4, Component C, Communicating with Families.

RESPONSE: In the front office is a Parent Resource Center with a variety of brochures in both English and Spanish. Topics include: Parents are Teachers Too; Children and Depression, Helping Children Cope (Grief, Divorce, Depression, etc.); Preparing for a Parent-Teacher Conference; Understanding Dyslexia; Seven Habits of Highly Responsible Students; Student Goal Setting; Attitude, etc. Additionally, the guidance counselor and Graduation Enhancement Technician work closely with parents on an individual basis in support of attendance and achievement.

RESPONSE: Information is provided through the school newsletter, parent handbook, School Advisory Council meetings, and family involvement events. Through Back-to-School Night and Report Card Conference nights, teachers provide information to parents about the curriculum and academic assessments in written and verbal formats, and translators are provided for non-English-speaking parents. Curriculum and assessment information and brochures are provided at School Advisory Council meetings and some of the family involvement events as well. Each year at a SAC meeting, laptop computers are set up for the meeting, and parents explore the state assessment website and actually take a sample FSA test to help parents understand the complexity of and the types of questions their children will see on the FSA.

The MTSS team meets with parents to determine appropriate interventions for students who are struggling academically or behaviorally. Further support is provided through the administrative team, guidance counselor and graduation enhancement technician, who collaborate with parents on an individual basis to support their children's improvement and success. Confidential records of the meetings are maintained. If parents are not satisfied with the school's support, school staff collaborates with district support to create alternative plans.

RESPONSE: At all parent engagement activities, the school provides translators (The front desk clerk, the guidance clerk, the Graduation Enhancement Technician, and at least four paraprofessionals are bilingual. Additionally, district staff employees volunteer to translate at larger events such as Report Card Conference Nights.). Invitations to events are sent home in Spanish, and all ConnectEd messages are recorded and sent in Spanish. Sign-in sheets at events are provided in English and Spanish, and any handouts or documents provided are provided in both languages. The ESOL parent meeting is presented in Spanish and the Powerpoint and all handouts are in Spanish. Report cards and progress reports are provided in Spanish for ESOL parents as well.

RESPONSE: Title I helps in the funding of most family engagement events if the event involves an educational component (flyers, educational materials, food for parents, supplies for hands-on activities). For example, no funding from Title I is used for Trunk-a-Treat, because the purpose of that event is not educational, but to provide a sense of community among Palm View's families. Transportation is offered to all School Advisory Council meetings and educational family involvement events, but parents do not ask for it. Title I funds the Graduation Enhancement Technician position and expenses such as transportation for making home visits.
