Chronic absenteeism negatively impacts student achievement and the transfer of information from the local school to the parents involved in the student's educational future.

Historically, high schools have limited attendance to parent meetings. We have made a significant effort to make ourselves available to parents at any request. If administration is not available, we have a new form for them to fill out and we will reply within 24 hours.
