Response: The Title 1 Annual Meeting will include an explanation of what Title 1 entails. It will also include a list of assessments students are required to take in each grade level and a summary of how these assessments will be used to determine student progress and what proficiency levels are expected. Parents will additionally receive a copy of the entire presentation to take home and refer to throughout the year which includes ways they themselves can become more involved.

The Title 1 parent survey and the Five Essentials survey gather input on the educational plan from parents that will be submitted and considered when making changes at Ochwilla. Data gathered from the surveys indicated that parents felt a need for increased communication from teachers. To increase communication throughout the year, each teacher has created a classroom web page and a weekly newsletter to keep parents updated on what is going on the classroom.

OES is wheelchair accessible for families who may need this provision when visiting the school. Onsite after school childcare is provided until 6:00 pm Monday through Friday.

Barriers

Transportation was a barrier for some parents last year. Parents who work also had difficulty attending school functions.

To overcome these barriers, we offer flexible parent meetings in the morning before school or in the evening after school. Teachers who stay late to attend meetings and other function are offered

comp-time. Parents with transportation issues are involved by phone, email, web page. In some instances parents are offered transportation by the administration.
