Response:

At the annual Open House, held on September 4, 2014, the Principal of Brentwood Elementary School of the Arts shared information with parents about school Programs. After a brief meeting, the Assistant Principal disseminated information about the Title I program, curriculum, assessments, and homework policies, and how parents can help at home. In addition, parents were given a Handbook that outlined parent and student roles and responsibilities for the school year. The handbook provided information on the District Calendar for holidays, report card dates, and weather days. The Handbooks also provided information on rituals and routines for the beginning of each day and the systems in place for dismissal. The handbook provided information on school wide programs, curricular expectations, how parents can request teacher-parent conferences, and opportunities for participation in PTA, SAC and other groups and committees related to the education of their child. The same information was provided in an informational packet distributed the entire week, for all parents who were unable to attend. Teachers used sign-in sheets and provided a copy to the assistant principal who will maintain documentation on the dissemination of information, distribution methods, and timelines.

In October, Brentwood teachers will discuss and get parent signatures on the School/Parent Compacts, as part of academic conferences after progress reports and the first report card periods.
