Response: MRES has formed a Parent Involvement Planning Team (PIPT) which includes two parents, two teachers, our Lead Teacher, and the Assistant Principal and Title I Paraprofessional. On May 1, 2014 members of the team attended a district Title I training covering the following topics: six types of involvement and their benefits, review and evaluation of the 2013-14 PIP, use of data to develop strategies, working with ELL families, and the district PIP. As PIP members leave the team new members will be recruited and trained. Anticipate barriers, research-based best practices, current data and the 2013-14 plan review/evaluation were used to develop goals and strategies for the 2014-15 plan. The team used the Parent Involvement Survey results to identify areas for improvement and created goals to address them. The PIPT will meet monthly to review, revise and evaluate plan strategies. The PIPT will garner support from stakeholders to implement strategies. In the fall the SAC will review the PIP and offer suggestions. The PIPT will then approve the plan. We will meet monthly with parents, faculty, staff and administration to allow for implementation and modification of the Title I Action Plan for Partnerships.
