The Parent Resource Center has made information and resources more available to parents, empowering them and providing the necessary tools needed so that they can help their child learn. Parents are invited and encouraged to attend field trips with their students, attend quarterly award ceremonies, and partake in events such as spooky night where teachers and parents read spooky stories to students the Thursday prior to Halloween. As well as strings, chorus, and dance performances that take place throughout the school year and show case students performing arts abilities and achievements.
