Flexible Parent Meetings

Pompano Beach Elementary will offer a flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, childcare, or home visits, as such services related to parental involvement [Section 1118(c)(2)].

Pompano Beach Elementary will schedule meetings to be held at various times during the day and evening to accommodate parents. Our school will hold our Annual Meet and Greet, which is an orientation for parents and students at the beginning of the year. Our Title I Liaison will provide parents with information about the schools' participation in the Title I program and encourage parents to be involved with reviewing and revising the schools Title I Plan.

Throughout the year, teachers will hold individual conferences with parents of the children in their classrooms. Parents will be given a summary of their students' test scores and an explanation of the interventions the teachers are using to assist the children in reaching their achievement goals. Parents will then be asked to be engaged in conversation in how they can support these efforts. Parents will also be given suggestions for coordinating

year with families of students in the class, along with specialized parent trainings.

The school will offer parents a special workshop each year to provide an explanation of the state-wide assessment systems, standards, and other accountability measures. Also the school will host a minimum of three (3) academic trainings specific to the subject areas of Reading, Math, and Science. At theses trainings, parents will learn how to assist their child at home with the academics that they are learning in schools, as well as provide specific FSA standardized testing information. As always, we provide childcare and translators when needed.

Building Capacity
