The APMS School Advisory Council (SAC), which represents all parents of students attending the school, meets throughout the year, developing and updating the APMS School Improvement Plan, Parent Family Engagement Plan, and Home/School Compact. Guidelines for the make-up of the SAC committee, which is comprised of parent representatives of the school's demographics, are adhered to in the selection process. Parents nominate other parents for the SAC positions and then those in attendance vote. The election of officers for the SAC committee were nominated and voted on for the selection. We have a District School Advisory Council (DSAC) representative for our school, and this person attends the DSAC meetings and shares school concerns if needed. All parents are invited via the Blackboard Connect call out system and an invitation /announcement is on the school's website and school social media sites for any school meetings, SAC meetings, and other parent/family engagement opportunities.

Parents are invited to attend the Title 1 Annual Meeting. An overview of "What is Title 1?" is shared through a PowerPoint presentation and discussed with parents in attendance. The Home/School Compact and Parent Family Engagement Plan is shared with parents also. The Parent Family Engagement Plan was discussed. Dates were discussed and shared with parents in attendance.

The committee addresses the importance of continued and increased parent family engagement in our school. The SAC committee will give input into the development of the Parent Family Engagement Plan (PFEP) and Home/School Compact. Avon Park Middle School will hold its annual Open House on August 9, 2018. During the classroom visits, teachers will provide additional information on the subjects they teach, assessment plans, and how parents can help at home. Teachers maintain sign-in sheets and provided a copy to the assistant principal who also maintains documentation on the dissemination of information, distribution methods, and timelines.

Parents are notified by the call out system of the Title One Annual Meeting and Orientation times for Avon Park Middle School. At the Annual Title One meeting of parents in September, Avon Park Middle School shared information about the Title I programs, the curriculum, and academic assessments. All notes/minutes from this meeting and all meetings will be kept in the Title One Resource Notebook.

The Blackboard Connect system is used to notify all parents in Spanish and English of upcoming events such as: 7th grade vaccination update, Dress Code Policies at Avon Park Middle School, Report Cards going home, informing parents of important FSA testing dates, bus information, weather reports (when necessary), school start-up times and dates, holidays, early release days, and SAC/PTO meeting dates and times.

Parents that attend the SAC/PTO meetings gain valuable information about the School Improvement and Parent Family Engagement Plans. We share data with parents about test scores and behavior issues. We ask for input from them on how we can better support them.

Parents are notified through phone calls in English and Spanish, notes in planners, progress reports, and report cards about concerns teachers might have with individual students by suggesting a parent conference. The school phone number is provided, and a translator is provided upon request. The ELL Para notifies the Data Operator if progress or report cards need to be in Spanish or English. All call-out information will be kept in the Title One Notebook in the Title One Resource Teacher/Dean's Office.

Important information is shared with the community via our school sign in front of the office. Important dates and events are posted for all to see when driving through parking lot or in front of the school.

The school will notify parents on the first day of school through the "Right to Know" letter that parents have the right to request information on the professional qualifications of the student's classroom teachers and paraprofessionals. The school will also notify parents when their student has been assigned or has been taught for four or more consecutive weeks by a teacher who is out of field. This notification will be a "Four Week Letter" to the parents.

The school will provide each family with an individualized student report of the child's performance on state assessments for those students taking the assessments. The score report

will be available to be picked up in the school front office when they are received from the state.

Avon Park Middle School provides families with an interpreter for conferences and meetings. Our ELL para helps teachers communicate with parents via phone, notes, or home visits. The ELL para helps students better understand the curriculum in their native language (Spanish). The administration, with the help of the ELL para, will monitor the home languages and provide additional languages when that population percentage increases to a level that is necessary and feasible.

APMS uses the Blackboard Connect system, which sends out messages in English and Spanish for our non-English speaking families. The LEA's migrant recruiter will communicate with migrant families if needed.
