The FLDOE summary of individual student performance on assessments is sent home with students if the materials are received prior to the end of the school year. Parents are notified at the end of the year that results received after that point are available in the front office throughout the summer. Those individual reports which remain in the front office at the beginning of the school year are sent home with students or to the enrolling school if a student has transferred. Prior year assessment results, ramifications and support ideas are discussed during conferences.

During Open house the FLA Parent Guides for curriculum are discussed and distributed by each homeroom teacher. During Academic Family Night parents are provided with sample grade level materials and suggestions of how simple tasks can be incorporated within at home activities. The monthly newsletter also has tips for parents.

Alta Vista enjoys support from many of the surrounding businesses, churches, and other organizations. These relationships are built by attending Chamber of Commerce meetings, direct solicitation, and offers to help from the various entities. The relationships are nourished by expressions of appreciation including using the marquee to acknowledge contributions, thank you cards, invitations to join SAC, invitations to school events, and an annual breakfast for those who have served our school. Alta Vista students participate with community events throughout the year which often creates an initial communication bridge between the school and outside interests.

Families are encouraged to maintain communication with their child's teacher throughout the year and to conference with the teacher by making a convenient appointment at least once a year to monitor student progress and to get ideas of how to support academic achievement at home. All stakeholders are invited to attend workshops and events at Alta Vista. Alta Vista communicates with families throughout the school year in a variety of methods including a monthly newsletter, flyers, marquee messages, whiteboard messages at car riders and the school website. Students have agendas, which are purchased with Title 1 funds, to facilitate a home-school connection. Most communications are in English and Spanish which is reflective of our population.

A partnership with Haines City High School provides student translators for events and meetings. Parents who cannot attend events are encouraged to call 863-421-3235 to make an appointment, at a convenient time, to receive the information delivered during any workshop or meeting. The school has handicapped parking at the front along with multiple ramps for wheelchairs. Hearing impaired assistance is available, from the District, with a 72 hour notice.
