Title I school program coordinators monitor that each Title I school is compliant.

We regularly monitor teacher qualifications for all teachers. After 4 weeks of instruction with a teacher who has not met the minimum qualifications as required by state statute, we will notify parents with the required documentation.

At the beginning of the year, we provide parents with information regarding state assessments, Florida Standards, and grade level expectations. This information is discussed at parent conferences and in informational brochures handed out at Open House. We will also provide updates in Newsletters, Wednesday Folders, Website, Annual Parent meeting, and Parent Nights. We provide information in various languages for parents.

Each Title I elementary school is required to hold at least one face to face conference with each student's parent/family.
