Other activities are: Grandparents' Day, school climate survey; district parent survey; PTA Meetings; Weekly School Newsletters, SAC meetings, PTA parent workshops, Spaghetti dinner & basket bazaar, science night, math night, activities sponsored through the Scenic Heights Neighborhood Association, Relay For Life, chaperoning field trips. Scenic Heights allows parents to participate in classroom activities designed to have parents interact with their children at school. Parents are notified of activities by newsletters, flyers, school website, and school phone messenger service. The school will monitor feedback via our annual climate survey.

When teachers return to Scenic Heights for pre-planning they are instructed to make phone contact with each parent on their class list to personally invite them to orientation which is scheduled a few days after teachers return. Information will be sent to parents in a timely manner. Every Monday, parents receive a "Bulldog Bulletin" which provides weekly and/or monthly school information. Students have daily planner and/or take home folders which allows for quick dissemination of materials. We also update our electronic marquee weekly and submit important information to parents via School Messenger. Parent conferences in Kdg & 1st grade will occur after 9 weeks of school; third grade conferences will occur immediately after round 1 of portfolio testing. The conference may include conversations about student progress, suggestions for home support, and volunteer opportunities. Parents may schedule conferences throughout the year as needed. Science night sponsored by teachers for parents and students in grade 3-5 take place in the fall. Students in grade 3-5 will sponsor a science night in the spring for students in grade Kdg-2. RtI meetings will be conducted for struggling students with invitations to parents. If a language or disability barrier exists, an interpreter will be provide the support needed to communicate effectively with parents.
