Mission Statement

Pompano Beach Elementary inspires a love of learning by meeting each child's academic, social, and emotional needs, while challenging all students to become productive citizens in our ever-changing global society.

Flexible Parent Meetings

Pompano Beach Elementary will offer a flexible number of meetings, such as meetings in the morning or evening, and may provide with funds provided under this part, transportation, childcare, or home visits, as such services relate to parental involvement [Section 1116(c)(2)].

Pompano Beach Elementary will schedule meetings to be held at various times during the day and evening to accommodate parents and their schedules. Our school will hold our Annual Meet and Greet, which is an orientation for parents and students at the beginning of the year. Our Title I Liaison will provide parents with information about the schools' participation in the Title I program and encourage parents to be involved with reviewing and revising the school's Title I and School Improvement plans.

Throughout the school year, teachers will hold individual conferences with parents of the children in their classrooms. Parents will be given a summary of their students' test scores and an explanation of the interventions the teachers are using to assist the children in reaching their achievement goals. Parents will then be asked to be engaged in conversation in how they can support these efforts. Parents will also be given opportunities for providing additional suggestions for coordinating school efforts to enhance student achievement.

The school will offer parents a special workshop each year to provide an explanation of the state-wide assessment systems, standards, and other accountability measures. Also the school will host a minimum of three academic trainings specific to the subject areas of reading, math, and science. Parents will be provided opportunities to

will be provided as needed. The principal will provide a “Munch-and-Mingle” opportunity to reach out to parents at different times of the day to be sure all parents are informed and kept abreast of school events.
