• The members of the SAC are comprised of lead teachers, voluntary community members, and parents from a diverse range of ethnic and socioeconomic backgrounds. We strive to have more than 50% of our SAC members be non-employee representatives. Parents from each class are invited to commit to joining the SAC committee at the Title I Parent Meeting through a sign-up sheet.

Reviewing

Joyce Bullock Elementary School will coordinate and integrate parent and family engagement programs and activities through various means, as well as:

VPK- The administrative team works with local preschools and school based VPK to offer professional development in academics and behavior management. Parents will be invited to attend trainings and Family Learning Nights as well. VPK parents are actively invited to participate in the decision making of the school and how to better the VPK program in the school. Students and parents are invited to attend sessions to better equip them in assisting with the academic and social development of their children.

(Title III)Rosetta Stone Tutoring Nights- ESOL parents work with the ESOL paraprofessionals, Mrs. Savona and Ms. Sosa, in the Rosetta Stone Lab weekly during our tutoring months. Classroom teachers assist the students with homework at this time. Paras also assists with the District ESOL meetings in Williston, communicating with our ESOL parents regarding the meetings, agendas, locations, and answering questions that they might have. They also provide translations as needed and provide surveys in Spanish.

Family and Behavioral Health Services- Administration, the School Counselor, and/or Social Worker will make referrals of families in crisis to our mental health counselor (Dr. Pratt). Teachers at Joyce Bullock Elementary have been trained in Youth Mental Health. Through the JBE PBIS initiative students requiring behavioral support are identified through problem-solving team meetings (PSTs). During these meetings data is collected and plans are made to provide students with tier 2 or tier 3 behavior support; building both school and parent relationships.
