1. Parents work long hours.
2. Limited financial resources which results in prioritization of financial expenditures. While most families have a vehicle, the cost of gasoline causes them to determine the necessity of the trip.

3. Barrier 3 – Use Schoolwide DoJo, FaceBook and FOCUS Parent Portal to push the invites and important information out to parents. Teachers will send academic and behavior information home monthly alternating times between interims and report cards.

What are the overarching outcomes/goals for the current school year for parent and family engagement?

Our school and district believe that a quality relationship between home and school is vital to a student's motivation, achievement, and well-being, and is committed to developing strong family partnerships that are supportive, informed, and effective.

Baseline enrollment in Schoolwide DoJo is 234 parents enrolled. This total is up from 127 out of 168 or 75% enrollments in the 2018-2019 school year. This is accounted for with students having a 2 or more parents/grandparents enrolled. We have 179 out of 199 or 90% of students with parents enrolled in September 2019. By the end of the third quarter, 95% of students (189 out of 199) will have parents enrolled in School-wide DoJo. This information tool is easily accessible by phone. Parents will then be able to respond to teachers or attend events that they have been made aware of.

COMMUNICATION AND ACCESSIBILITY

A variety of parental involvement activities at a variety of times during the day will be planned to ensure that each parent has ample opportunity to participate. Multiple sources will be used to communicate events for parents to be involved in. Book Bingos are at 5:30 p.m. Doughnuts for Dads and Muffins for Moms will be at 7:00 a.m., the Veterans Assembly will be at 8:00 a.m. and Kindergarten Orientation will be at 9:00 a.m.

Migrant partnership with Alachua County provides support and interpreters for migrant students with adequate scheduling. The Title 1 district office will provide information in other language as needed. The ESE department provides support for needs related to students with disabilities to ensure that all students and parents can participate.

English is the primary language spoken by parents and families at Lawtey Elementary School. In the event a non-English speaking child were to enroll, the district ELL contact will support forming communications in languages that the parents and families can understand. The parent of the Gujarati student does speak, read, and write English.

What are the different languages spoken by students, parents and families at your school?

English and Hindi are spoken in 1 family (2 students) home. The students passed the ESOL test and are not considered ESOL students.

- (1) The Title 1 Annual Meeting will be held in conjunction with the Meet and Greet prior to the start of school. Parents will be made aware that we receive Title 1 funds which are used to secure two highly-qualified paraprofessionals.
- (2) An information letter about Title 1, Part A as well as the Parents Right to Know is sent home during the first two weeks of school.
- (3) The Title 1, Part A plan will be available thru the Bradford County School District website.
- (4) Parents will be made aware of site specific events and/or district events thru a flyer sent home via backpacks, Class DoJo and FaceBook posts.

- (6) iReady performance reports explaining the level of their child's performance in math as well as the growth target by year end are sent home with the first report card in October.

- (1) Our Title I/School Advisory Council composed of teachers, staff and parents will work with the principal to make informed decisions.

1. Late July: Principal met with District Title 1 Director to outline specific information to be shared.
2. August 8: Captive parent audience prior to the Meet and Greet. Principal shared information about TIPA budget, anticipated expenditures, and parent and family engagement activities.

Describe the nature of the Title I, Part A Schoolwide program that will be shared with parents during the Annual Meeting.

The schoolwide TIPA budget met with a significant reduction from 2017-2018 as two large secondary schools were included in the District TIPA plan. The allocated funds for 2019-2020 will be used for two paraprofessional salaries, curriculum supplements and supplies.

The Annual Meeting provides a venue to celebrate the progress of our school, aka, "B" School Grade for 2017-2018. Subgroup breakdowns are shared at the meeting as well as the Title 1/SAC plan for a social emotional curriculum including Growth Mindset. Information on StepUp for Students opportunities is sent home. The verbal announcement of the Parent's Rights under TIPA are followed up by a backpack letter within the first two weeks of school.

How will the school ensure parents without access to technology will receive notification of parent events, communication, information about parent events, school updates, and student progress updates?

90% of Bradford parents responded that they have Internet access. 100% of students at LES have phone numbers assigned to their FOCUS account. Schoolwide DoJo reaches more parents than email, therefore, LES mainly uses this method to communicate with parents about events, academics, behavior, and announcements of general interest to the school.

In addition, weekly progress logs and information fliers are sent home in the Tuesday Folder. A Monthly School Newsletter is distributed, and information flyers posted in the front reception area of the school.

Required Developmental Meeting

The Developmental Meeting is held at the end of the year. It can be looked at as an End of Year evaluation of your Title I, Part A Parent and Family Engagement process. In late April/early May, LES's final School Advisory Council meeting will provide a review of Parent and Family Engagement activities conducted throughout the year. Feedback responses collected throughout the year post events and feedback from the School Climate Survey will be reviewed.

Student progress to date will be discussed, however, no end of year data will be available until late May/early June at which time a depth of analysis on student achievement may redirect plans for the 2020-2021 school year.

Formatted in a family friendly venue, LES will provide events to help parents understand math and reading standards based on the grade level Florida Standards of their child. Information will be shared on the performance level in math and reading based on baseline data and progress monitoring in printed reports and face to face conferences. Opening access through technology into Pathblazer reading intervention program for home use will further equip parents with tools to help their child learn.

How will the school implement activities that will build relationship with the community to improve student achievement?

The Bradford County Education Foundation (BCEF) is a strong community partner. The BCEF continues to support family literacy by donating a \$6 Book Fair coupon for each student to select a book during the school's event.

The local Kiwanis Club sponsors a Terrific Kid program which brings parents to school to celebrate the social-emotional and academic accomplishments of their child.

Back to School supplies are donated annually by the BCEF, community churches and other community members.

Chemours is working with us to fund a STEM grant for a lab which will also fund materials for participation in the Legos Robotics Competition. They will also send guest speakers from the industry to instill a vision of STEM careers in our students.
