Differentiated Accountability (DA) Rule Development

The purpose of this rule amendment is to revise rule language and forms to reflect changes made to Section 1008.33, Florida Statutes, during the 2017 legislative session as a result of House Bill 7069 which amended many provisions addressing school improvement.

Proposed Changes

- Criteria for Implementing a Turnaround Option Plan (TOP)
- 4 Turnaround Options
- Targeted Support and Improvement (TS&I)
- Comprehensive Support and Improvement (CS&I)

Proposed Changes

- TOP 1 will include the Memorandum of Understanding (MOU) due to DOE by September 1
- TOP 2, Initial Turnaround Plans, are due to DOE by October 1

Proposed Changes

- Removed hybrid as a turnaround option
- Removed the planning year before turnaround implementation
- Removes the 3 year monitoring requirement of former “F” schools
- Replaces the District Improvement and Assistance Plan (DIAP) with the District Strategic Plan (DSP)

Outline of Proposed Changes

- Streamlining the 8-Step Planning and Problem Solving process
- Removing the definition of Annual Measurable Objectives (AMO), Florida's Continuous Improvement Model (FCIM) and Lesson Study
- Revises incorporated forms used by school districts to align with state statute and the proposed rule
 - School Improvement Plan (SIP)
 - Turnaround Option Plan-1 (TOP-1)
 - Turnaround Option Plan-2 (TOP-2)
 - Differentiated Accountability Checklist-1 (DA-1)
 - Differentiated Accountability Checklist-2 (DA-2)
