







## **DA Highlights**

out of 223 DA schools exited DA in 2017-18

68 % of 2017-18 DA schools exited DA

71.3 % of 2017-18 DA schools improved their 2018 school grade



## **DA Rule Development**

- Revises definitions and timelines
- Revises forms
  - DA-1 Checklist for District Support
  - DA-2 Checklist for School Support
- Creates new streamlined forms
  - Turnaround Option Plan—Step 1, District-managed Turnaround
  - Turnaround Option Plan—Step 2, District-managed Turnaround
  - Turnaround Option Plan—Step 1, 3-Options
  - Turnaround Option Plan—Step 2, Reassignment/Closure
  - Turnaround Option Plan—Step 2, Charter
  - Turnaround Option Plan—Step 2, External Operator/Outside Entity



## **District-managed Turnaround Plan**

#### 2 Assurances

- District Capacity and Support
  - Dedicated district position to lead the plan
  - Align instructional programs and progress monitoring to Florida Standards
- School Capacity-Leaders and Educators
  - Ensure the leaders have proven turnaround success
  - Ensure the school has priority in hiring and that effective teachers are staffed at the school
  - Ensure that teachers state VAM percentages are in balance with the district/state average

#### **Required Documentation**

Submit MOU and instructional rosters



## **3 Other Turnaround Options**

- Reassignment/Closure (RC)
- Charter (CH)
- External Operator/Outside Entity (EO)



## Reassignment/Closure (RC)

#### 3 Assurances

- Close and reassign students to higher-performing schools with a "C" or higher
- Monitor reassigned students and report their progress to the department for three years on a quarterly basis
- Ensure teachers rated as Unsatisfactory or Needs Improvement based on the three-year aggregated state VAM rating and administrators are not reassigned to other DA schools within the district



## **Charter (CH)**

#### 4 Assurances

- Close the school and reopen as a charter or multiple charters
- Enter into a contract with the charter organization following established district policies and procedures
- Select a charter organization that has a record of school improvement in turning around schools
- Ensure that teachers rated as Unsatisfactory and Needs Improvement based on the three-year aggregated state VAM rating and on the district's approved evaluation system are not hired




## **Outside Entity/External Operator (EO)**

#### 4 Assurances

- The district shall select an EO that has a record of school improvement in turning around schools
- The district and the EO shall ensure the incoming principal and school leadership team have a successful record in leading turnaround schools
- The district and the EO shall ensure that teachers rated as Unsatisfactory and Needs Improvement based on the three-year aggregated state VAM rating and on the district's approved evaluation system shall not be hired
- The district shall enter into a contract with an EO to operate the school following established district policies and procedures

#### **State Board Consideration**

The State Board shall consider, at a minimum, the following factors:

- The strength of the turnaround plan
- Whether the plan is sufficiently tailored to address the causes of low performance
- The prior record of the proposed school leadership team in improving low performing schools
- The school district's history of success with this school and other low performing schools in the district
- The extent to which the recommendations of the RED and the Department have been incorporated into the district's turnaround plan



## **State Board Approval**

- The SBE shall approve a Turnaround Plan when it is found to create the conditions to improve the school's grade to a "C" or higher during the two-year implementation period
- The SBE is authorized to approve, conditionally approve or deny the plan
