## Purpose and Outline of the SIP

The SIP is intended to be the primary artifact used by every school with stakeholders to review data, set goals, create an action plan and monitor progress. A corollary at the district level is the District Improvement and Assistance Plan (DIAP), designed to help district leadership make the necessary connections between school and district goals in order to align resources. The Florida Department of Education encourages schools to use the SIP as a "living document" by continually updating, refining and using the plan to guide their work throughout the year. - Determine how they will monitor progress toward each goal (Step 8)

## **Differentiated Accountability**

#### 1. School Mission and Vision

In doing this, we will ensure that all students make minor and major growth in learning and achievements.

Our vision is to provide a learning environment in which education is purposeful to students, faculty and staff. Through purposeful education, we will foster a love of learning and develop skills for success, seizing all opportunities to teach and learn as they present themselves.

Myrtle Grove K-8 Center implements a variety of instructional best practices in order to build a cultural and academic connection among teachers and students.

-Student Growth Measures are developed for teachers to monitor student academic progress.

-Professional Development is offered for teachers to enhance their instructional delivery.

-Coaching & Collaboration is implemented for teachers and curriculum support specialists to develop effective instructional action plans.

-Observation and Feedback is conducted among administrators and teachers to offer assistance and feedback about instructional planning and delivery.

-Learning Environment is monitored and encouraged to provide students with an inviting and educational environment needed to maximize their learning.

## b. Describe how the school creates an environment where students feel safe and respected before, during and after school.

Myrtle Grove K-8 Center has developed and implemented different procedural safety guidelines to assist in the daily operational procedures. These guidelines focus on student safety and preventive strategies.

-A school-wide Discipline/ Safety Committee has been established to keep all faculty, staff, parents, and students aware of discipline and safety procedures.

-Values Matter Initiative is implemented and promoted among all staff, faculty, and students.

-Monthly assemblies have been scheduled to address student behavior patterns and/or celebrations. -School Arrival/ Dismissal Procedures have been implemented and disseminated to all school personnel and practiced on a daily basis.

-Parent/ Student Handbook has been presented to parents and students to raise awareness of all school rules and regulations.

-Security monitors have been hired and placed in strategic areas to maintain student safety.

Myrtle Grove K-8 Center practices systematic and individualized strategies for achieving social and learning outcomes that maximize student learning. Some of these practices include, but are not limited to:

- Self-management programs

- Alternatives to out-of-school suspension
- Effective Academic Support
- · Social skills teaching
- · Positive, proactive discipline
- Teaching school behavior expectations

Also, a school wide plan is implemented which requires each teacher to develop a classroom management plan with the assistance of their students.

Myrtle Grove K-8 Center implements a proactive approach to problem solving, continuous professional learning in order to provide the very best approach to supporting students. Honesty, integrity and confidentiality is provided throughout the process. This supports and guides data to ensure that the best practices and individualized approaches with flexibility will ensure each child's success.

Myrtle Grove K-8 Center implements the Rtl process with fidelity throughout the entire school year. -Interventionists are hired early in the year to address students that start the school year as a retained student or students that are in the Rtl process.

-Students in grades K-8 are monitored through I'Ready data, monthly topic/ unit assessments or content baseline assessments each grading period to determine eligibility for intervention.

-Parent meetings are scheduled when students move from one Tier to the next.

-The EWS team meets weekly to discuss student progress and develop a plan of action.

To build positive relationships with parents, numerous incentives, activities, and programs are implemented. The Community Involvement Specialist hosts monthly meetings for parents and invites instructional coaches to present information on reading, math, science, social science and topics that increase parents' conceptual understanding, enabling them to assist their children. The Community Involvement Specialist also assists and encourages participation from school volunteers, so they have a more active role in the school. Parents are encouraged to attend the Parent Resource Center which is open daily and provides a comfortable environment to receive assistance. Parents are informed of activities and school events through Connect-Ed, monthly calendars, social media and the school's website.

# 2. Describe the process by which the school builds and sustains partnerships with the local community for the purpose of securing and utilizing resources to support the school and student achievement.

Myrtle Grove K-8 Center sustains partnerships with the local community to support student achievement by:

-Hiring a Community Involvement Specialist (CIS) at the beginning of the school year.

-Consistent meetings between the CIS and administrators are scheduled to address on-going student and parent issues.

-Ensuring that all community partners share a common vision- Introduction meetings take place with administration to establish the school goals.

#### Title I, Part A

Services are provided to ensure students requiring additional remediation are assisted through extended learning opportunities (before-school and/or after-school programs and Saturday Academy). School based, Title I funded Community Involvement Specialists (CIS), serve as bridge between the home and school through home visits, telephone calls, school site and community parenting activities. The CIS schedules meetings and activities, encourages parents to support their child's education, provide materials, and encourage parental participation in the decision making processes at the school site. Curriculum Coaches develop, lead, and evaluate school core content standards/ programs; identify and analyze existing literature on scientifically based curriculum/ behavior assessment and intervention approaches. They identify systematic patterns of student needs while working with district personnel to identify appropriate, evidence-based intervention strategies; assist with whole school screening programs that provide early intervention services for children to be considered "at risk;" assist in the design and implementation for progress monitoring, data collection, and data analysis; participate in the design and delivery of professional development; and provide support for assessment and implementation monitoring. Parents participate in the design of their school's Parent and Family Engagement Policy (PFEF), the school improvement process and

the life of the school and the annual Title I Annual Parent Meeting at the beginning of the school year. The annual M-DCPS Title I Parent/Family Involvement Survey is intended to be used toward the end of the school year to measure the parent program over the course of the year and to facilitate an evaluation of the parent involvement program to inform planning for the following year. An all out effort is made to inform parents of the importance of this survey via CIS, Title I District and Region meetings, Title I Newsletter for Parents, and Title I Quarterly Parent Bulletins. This survey, available in English, Spanish and Haitian-Creole, will be available online and via hard copy for parents (at schools and at District meetings) to complete. Other components that are integrated into the school-wide program include an extensive Parental Program; and special support services to special needs populations such as homeless, migrant, and neglected and delinquent students.

The major initiative of the LLT this year is to increase the rigor of instruction provided by teachers in grades K-8th. Florida state standards will be analyzed in depth through collaborative planning with teachers, coaches, and administration. This will maximize learning proficiency. LLT members will provide teachers with all pertinent information received in professional development sessions to plan for effective lessons.

One venue for encouraging positive working relationships with teachers is participation in Learning Team Meetings and or Professional Learning Communities. The master schedule has been designed to provide consistent time for teachers to meet by common content. Research-based protocols are utilized to focus the meetings on students' academic needs and how students might be assessed. Student improvement is monitored and instruction is modified as needed based on decisions made through collaboration.

The school's strategies to recruit and retain highly qualified, certified-in-field and effective teachers include:

1. Weekly meetings with instructional coaches and grade level teachers to provide feedback and assistance in effective planning- Principal, Assistant Principal

2. Professional Development through opportunities on differentiated instruction in all content areas-Principal, Assistant Principal, Reading Coach, Math Coach, and Grade Level Chairs.

3. Provide all teachers with common planning time to promote collaboration and sharing of best practices- Principal, Assistant Principal, Instructional Coaches

4. Establish and maintain relationships with colleges and officials in the field of education to promote the District and school educational initiatives.

The school's mentoring program includes:

- 1. Providing assistance from exemplary teachers during planning time.
- 2. Scheduled time to meet with instructional coaches to enhance instructional practices.
- 3. Providing assistance from administrators focused on feedback from classroom observations.

Myrtle Grove K-8 Center develops ongoing opportunities for teachers to unpack the Florida Standards and to plan and discuss content curriculum that aligns to the standards. These conversations and learning opportunities promote dialogue that can dismiss misunderstandings as well as opportunities for growth in instructional practice, curriculum, and the standards. McGraw Hill and Houghton Mifflin

and I-Ready Assessment tools are some of the instructional resources utilized by teachers that are aligned to the Florida Standards.

#### b. Instructional Strategies

1. Describe how the school uses data to provide and differentiate instruction to meet the diverse needs of students. Provide examples of how instruction is modified or supplemented to assist students having difficulty attaining the proficient or advanced level on state assessments.

Myrtle Grove K-8 Center ensures every teacher contributes to literacy improvement of every student by:

•Holding meetings on a regular basis to make decisions about literacy instruction. Student data is analyzed and compared to expectations found in the Language Arts Florida Standards (LAFS) and Mathematics Florida Standards (MAFS).

•Utilizing a balanced literacy approach that includes whole group, small group and one-on-one instruction based on student needs

•Creating a schedule with an uninterrupted 90 minute reading block

•Creating a schedule with an additional 30 minute reading intervention block (for selected students) •Providing instruction based on student needs during DI.

Providing instruction aligned with the Language Arts Florida Standards for grade levels
Providing resources to support instruction (classroom libraries, texts to support units of study, leveled

books for small group instruction) •Administering assessments which measure instructed standards

•Progress is monitored at grade-level meetings, as well as in data-chats

•Conducting data chats with students

A teacher per grade level has been identified to begin tutoring services after school hours. Tutoring will offer differentiated instruction in core subject areas that include Reading, Writing, Mathematics, and Science. There will also be tutoring in the computer lab to enhance learning in reading and mathematics.

Title I Administration assists the school by providing supplemental funds beyond the State of Florida funded Voluntary Pre-Kindergarten Program (VPK). Funds are used to provide extended support through a full time highly qualified teacher and paraprofessional. This will assist with providing young children with a variety of meaningful learning experiences, in environments that would give them opportunities to create knowledge through initiatives shared with supportive adults.

"Welcome to Kindergarten" program has been established to build partnerships with local early education programs. Through this joint venture, parents and children will gain familiarity with kindergarten as well as receive information relative to the matriculation of students at the school. The principal will also meet with the Pre-K center directors of neighborhood centers.

Main office staff will distribute "Smooth Sailing" kindergarten preparation brochures and other documents to interested parents throughout the year.

All students were assessed entering Kindergarten using FLKRS.

-Data was used to plan instruction and determine the need for interventions.

-Core academic and behavioral instruction is based on data and includes social skills instruction.

In an effort to minimize challenges and maximize student achievement, transition strategies for 8th grade students have been developed.

-Counselors use specific lessons from the Standards-Based Student Development Program (SBSDP) from the Student Services Department to help students learn about the Senior High School Program of Study and course requirements needed for graduation.

-Myrtle Grove K-8 Center participates in an articulation process with our feeder pattern high schools for students to see what programs are offered by each high school.

-Myrtle Grove K-8 Center holds an annual high school fair to invite schools that have magnet programs to showcase their programs.

-Myrtle Grove K-8 Center participates in the Recruitment for Magnet High School Program by attending fairs from inviting schools.

-Counselors keep parents informed of open enrollment for magnet high schools programs and their requirements.
