#### Purpose and Outline of the SIP

The SIP is intended to be the primary artifact used by every school with stakeholders to review data, set goals, create an action plan and monitor progress. A corollary at the district level is the District Improvement and Assistance Plan (DIAP), designed to help district leadership make the necessary connections between school and district goals in order to align resources. #### **Differentiated Accountability**

### a. Describe the process by which the school learns about students' cultures and builds relationships between teachers and students.

Meet the Teacher, School-wide theme: Leader in Me utilizing Stephen Covey's The 7 Habits of Happy Kids, Teacher-Student conferences, Action Teams, Student Lighthouse Team & community circle are all components in establishing and maintaining positive relationships between teachers and students.

### b. Describe how the school creates an environment where students feel safe and respected before, during and after school.

The school-based leadership team and our Lighthouse Team, promotes the implementation of The 7 Habits of Happy Kids in all settings to build positive behaviors within the school community. Through Leader in Me Professional Development sessions, leadership will be implemented throughout our campus.

Students are expected to exemplify the 7 Habits and will receive positive recognition on a regular basis..

Through teacher discretion, students are selected to be recognized at a monthly Outstanding Student Sign celebratory assembly, where they receive a personalized letter to their families and a yard sign that will be displayed in their homes for one month.

Safety Patrol students promote a safe environment before, during and after school.

In response to the 2016-2017 VCS#HELLO initiative, the Sunrise Hello Team is comprised of twelve 5th graders whose mission is to help welcome our students to school, holding signs and verbally greeting our arriving students and adults.

Heart Pals are teacher mentors that are partnered with identified at-risk students.

Our special needs students use the RULER program for social and emotional support during the school day. The RULER program is taught and used in every ESE classroom.

c. Describe the schoolwide behavioral system in place that aids in minimizing distractions to keep students engaged during instructional time. This may include, but is not limited to, established protocols for disciplinary incidents, clear behavioral expectations, and training for school personnel to ensure the system is fairly and consistently enforced. The 7 Habits, which are: Be Proactive, Begin with the end in mind, Put first things first, Think Win-Win, Seek first to understand, then to be understood, Synergize, Sharpen the Saw are explicitly taught and reinforced in all settings throughout the year.

A school wide positive behavior incentive program tied to our Leader in Me theme has been developed.

Sunrise Common Areas Expectations and Rules language is displayed throughout our campus.

Instructional time is a priority and protected by the principal, which is evidenced by the school infrastructure regarding student and parent accountability for absences and tardies, no non-essential announcements, and student misconduct being handled immediately and minimal interruption to instruction.

### c. Describe all intervention strategies employed by the school to improve the academic performance of students identified by the early warning system.

Sunrise Elementary consistently monitors attendance on a daily and weekly basis and provides incentives for reaching daily attendance goals.

Those students who are consistently tardy or absent from school, there is communication with the families from guidance office as well as from administration office.

A behavior specialist is available full time on our campus to provide support for students in any classroom, but most particularly in the ESE settings to develop behavior management plans, support teachers, and teach students appropriate replacement behaviors. Our guidance office also provides lessons and support to students and teachers when behaviors are affecting the learning of students in the classroom.

Students with level 1 on their ELA and/or Math FSA assessments are flagged and continually monitored for academic progress. They are provided intensive intervention from one or a combination of an ESE teachers, ELL teacher and/or intervention teacher in small group settings.

Administration and behavior support team continually reflect on alternatives to suspension from school when possible based on individual need of the student(s). Behavior support team members continue to monitor and support school wide and classroom based preventative behavior systems as well as instilling Leader In Me philosophies across the campus.

Mentoring programs for students is also available for students who are struggling with attendance, behaviors, or low academic performance.

Sunrise Elementary actively seeks business & community partnerships throughout the school year by personal contacts with local businesses. An office specialist, parent involvement liaison, and PTA continue to reach out to our community. For example:Chick Fil-A, Subway, McDonald's, Dunkin Donuts, and Domino's donations support student academic assemblies. Sunrise has also partnered with

Deltona's local skating rink, The Rink, hosting monthly skate nights, promoting family involvement. Sunrise has partnered with Kona Ice as well.

In our Project Heat and She to She programs, community members are invited to participate, mentor and contribute to the well being of our students.

#### b. Duties

### 1. Describe the roles and responsibilities of the members, including how they serve as instructional leaders and practice shared decision making.

The school based MTSS leadership team identifies school based resources (both materials and personnel) to determine the continuum of academic and behavioral supports available to students at the individual school site. Academic and behavioral data are considered in order to determine priorities and functions of other existing teams (e.g., Problem Solving Teams, Behavior Leadership Teams, and Professional Learning Communities). The Problem Solving process (i.e., Problem Identification, Analysis of Problem, Intervention Implementation and Response to Intervention) is used as the way of work of all teams and not just for individual student concerns. Adherence to the Problem Solving process ensures that individual, class-wide, and school-wide issues are addressed systematically with data; that interventions (supports) are tiered to the targeted problems; and that a plan is in place to monitor progress. The school-based MTSS leadership team meets regularly throughout the school year in order to address the academic and behavioral needs that develop throughout the year, as well as to monitor outcomes of supports and interventions.

2. Describe the process through which school leadership identifies and aligns all available resources (e.g., personnel, instructional, curricular) in order to meet the needs of all students and maximize desired student outcomes. Principal: Provides a common vision for the use of data-based decision-making by promoting the Volusia Proficiency Model. Ensures that educators are implementing the district's Progress Monitoring Plan (PMP) accessible through the K-12 curriculum link of the webpage and the VCS Problem Solving/Rtl model (i.e., Problem Identification, Analysis of Problem, Intervention Implementation and Response to Intervention) for those students who do not respond effectively to core instruction. For those students who do not respond positively to interventions beyond core, ensure that the school's Problem Solving Team (PST) is accessed as needed. Ensure adequate professional development is scheduled for faculty. School Psychologists will provide/facilitate training on skill building and understanding of the components of PST/Rtl. Support the school's team in the completion of resource mapping (academic and behavioral) with focus on standard protocol interventions in order to enhance implementation of PST/Rtl. Communicates with parents through school newsletters, relevant meetings, and the sharing of the parent link of the VCS Problem Solving/Rtl website (under Psychological Services) in order to address the purpose of PST/Rtl in meeting student needs and to address frequently asked parental questions. In addition, parents are provided information about PST/Rtl at PST meetings.

School Psychologist: Assists schools in interpreting individual, class-wide, grade-level and schoolwide data in order to develop appropriate targeted interventions linked to the academic or emotional/ behavioral problem. Ensure that on-going progress monitoring is in place in the area of intervention to most appropriately determine the student's response to intervention. Provides professional development to staff on PS/RtI.

Curriculum Leadership Team acquire knowledge through district trainings, process the knowledge to plan for dissemination.

Under Title I Part A our school works with outside agencies that provide specific services to targeted children and their families. These organizations team with our school to provide specific services to students, parents, and staff, including all special needs groups. It is the expectation of those involved in these partnerships that the activities and services will benefit the students by providing the children served with the support, tools, and materials they need to be ready to learn as they move down the appropriate path to graduation.

The District Migrant Education Program Coordinator, Migrant Advocates and Migrant Recruiters work

Students are transitioned from DJJ centers back into the district schools with a transition plan to ensure academic and social success.

The district receives federal funds to provide access to Professional Development activities for public and private school teachers and principals in the core subject areas to ensure quality instruction and student success.

The District ESOL Coordinator and staff provide ongoing support and Professional Development to teachers to ensure instructional best practices are utilized. In order to begin evaluating the effectiveness of last year's school improvement plan, our initial School Leadership Team met to engage in Step Zero during our 2-day meeting at River Springs Middle School in June 2018. Our School Leadership Team will share results with the faculty, as well as the School Advisory Council to receive input.

Members of the School Leadership Team that attended the River Springs Middle School meetings, met with Sunrise grade level team leaders to continue the analysis of our school's progress and begin the development of the 2018-2019 SIP. Sunrise SAC reviews and assists with monitoring school-wide data and provides input to the School Improvement Plan on a monthly basis. Weekly PLC meetings with individual groups provide monitoring of student achievement, which results in data driven differentiated groups. Due to our weekly PLC process, frequent Annual Title I informational sessions, and monthly SAC parent input, the Sunrise School Improvement Plan is a living document.

The school's annual budget and plan are shared for input and discussion at the first meeting of the SAC each year. Updates on the school's budget, spending and progress indicators are shared at monthly SAC meetings.

#### b. Duties

#### 1. Describe how the LLT or similar group promotes literacy within the school, if applicable.

The School Leadership Team meets bi-weekly to analyze school-wide data in all areas of literacy. The weekly PLC meetings, which have literacy team representatives, focus on student progress monitoring and effective delivery of core instruction and interventions (Walk-To).

Our school media specialist provides support to teachers in the classroom on incorporating literacy across subject areas. The focus is to provide support for reading and writing in every classroom every day.

The school supports a One Book, One School event yearly where our media specialist along with other teachers do school wide or grade level wide book studies/read-a-louds. Members of our community are asked to come in to read to our students and participate in our One Book, One School year end event. This event is typically scheduled around the same time as our Scholastic Book Fair.

Common planning, Professional Learning Communities and academic coaching help build positive, collaborative working relationships between teachers. Common planning allows teachers to participate in weekly PLC meetings. Through the PLC structure teachers are encouraged and supported to work

together on common goals and engage in reflective dialogue.

The use of an academic coach to assist with teacher collaboration and professional development plays a significant part in designing differentiated instruction to meet student needs and encourage the collaborative process. Administrative walk-throughs and coaching visits provide data to identify areas in which additional follow-up coaching is needed.

All new/beginning teachers are paired with a district PAR teacher for formal mentoring/coaching support. In addition, school-based teacher leaders within each PLC provide mentoring as needed.

Two academic coaches receiving training from the New Teacher Center will each have a caseload of 15 teachers at a time, servicing all K-5 General Education teachers on campus plus some ESE and EBD teachers. Level A Coaching Support will consist of one-one-coaching for an entire school year with a total of 40 hours of direct and personalized PL with teachers in years 1-3 years, new to their content, or whose students are identified as at-risk based on data. Level B Coaching Support will include one-on-one coaching for an entire semester with a total of 20 hours of direct and personalized PL with teachers who are interested PL with teachers who are new to their grade level, new to Sunrise, or teachers who are interested in improving their are of practice. PLC Coaching Support for an entire year will include teams of teachers in the same grade level or content.

The Volusia County Curriculum Team leads teacher teams to create curriculum maps, modules, and resources for all grade levels and content areas aligned to the Florida Standards and educational shifts. Additionally, teacher teams create formative & summative assessments to monitor student achievement.

Professional Learning Communities, School Leadership Team, Lighthouse Team meetings and oneon-one academic coaching help ensure that instruction is aligned to the Florida Standards, wellpaced, engaging and rigorous. School-Based Early Release Professional Learning sessions have been designated for ensuring support from school-wide and district expertise.

Regional Early Release Professional Learning sessions have been designed by the district for grade and subject-specific tracks in which Sunrise teachers will collaborate with teachers from across the county to deepen understanding of the Florida Standards and plan standards-aligned lessons, embedding the shifts. Sunrise is able to help choose the professional tracks each teacher and our school will day during professional learning opportunities.

Common planning allows teachers to participate in weekly PLCs to regularly review formative & summative assessment data and continuously adjust our instruction accordingly. During weekly PLCs, assessment data is used to identify groups of students to receive targeted instruction during intervention. Teachers, alongside the academic coaches create targeted instruction lessons based on the instructional shifts. When necessary, PLCs make recommendations for students to be reviewed and assisted by the school's early warning system (EWS) team and problem solving team (PST). Additionally, grade level meetings are held to review student data and address specific academic and behavioral concerns across the content areas.

A specifically designed system for monitoring and tracking our lowest quartile students is in place and continually updated by the instructional coaches and the individual teachers as well as the support teachers such as ESE, ESOL and intervention teachers.
