The DVA will address building a positive school culture and environment through continuous communication with students and parents via technology. Students will receive announcements keeping them informed as to the upcoming requirements academically. Students and virtual teachers schedule individual DBA's which help the students review and prepare for upcoming unit tests. These may be conducted via phone or zoom. A virtual open house is conducted to meet the teachers and ask questions prior to the start of school. Students are required to check in daily to their classes and attend all live sessions notated in the student/ parent handbook. Students are required to come to the middle school in person when they fall behind academically and attendance. This will ensure they improve their scores in that subject to pass.

The stakeholders are the parents, students, virtual teachers, principal, guidance counselor, and the social worker. We have a team of people working collaboratively to make sure each virtual student is attending, participating, completing the course work, and thriving both academically and socially. Teachers, administration, social worker, and guidance counselor are diligently observing and checking to make sure each student is succeeding and if they are not their needs will be assessed and attempted to help them.
