For grades K-5, students' progress is monitored through the I-Ready Diagnostic that is administered three times per year, after each assessment period. For K-2nd grade students, additional progress monitoring data is collected and analyzed with FLKRS and Wonders' Benchmark Unit Assessments. For Grades 3rd-5th, additional progress monitoring assessments will include results from the I-Ready Standards Mastery. Teachers will use the data to drive instruction based on student needs. All teachers are directed to maintain portfolios of student work with corrective feedback in their classrooms to provide a fuller picture of student progress towards mastery of grade-level standards. With the current focus on text-evident writing and comprehension of grade- level complex text, portfolios are a critical tool for school-based monitoring.
