What trends emerge across grade levels, subgroups and core content areas?

Across grade levels, 5th grade math proficiency was lower than 3rd and 4th grade. Girls/Boys subgroup even though girls demonstrate proficiency, girls are performing lower than boys in math (3-5). In 3rd - 5th grade ELA and Math, the Hispanic subgroup of students performs at rate less proficient than their white counterparts. In the ELL subgroup, student perform at a less than proficient rate that non-ELL peers.

What data components, based off progress monitoring and 2022 state assessments, demonstrate the greatest need for improvement?

"3rd - 5th Grade ELL, ELA performance (FSA): 33.3% nonproficient
 3rd - 5th Grade ELL, Math performance(FSA): 38.9% nonproficient
 5th Grade Math (FSA): 55.7% nonproficient"

What were the contributing factors to this need for improvement? What new actions would need to be taken to address this need for improvement?

Factors contributing to the low performance in ELA and Math proficiency and learning gains include disruption in instructional continuity due to the pandemic that further widened gaps in students'

foundational skills. Actions to support improvement in these areas will include frequent formative progress monitoring with target support and acceleration in identified areas of need.

What data components, based off progress monitoring and 2022 state assessments, showed the most improvement?

Math in 4th grade improved from 51% previous year to 71% this school year.

What were the contributing factors to this improvement? What new actions did your school take in this area?

Deliberate monitoring of specific student groups contributed to this improvement. Actions included focus on the monitoring of the lowest 30% of students, acceleration of high level 1 and high level 2 and level 3 students along with standards based tutoring.

What strategies will need to be implemented in order to accelerate learning?

Purposeful planning and PLCs, including but not limited to instructional coach, AP, and P being present and planning and discussing data and plans. Using district provided resources, planning differentiation purposefully, and focusing on text complexity and readability from students' eyes.

Positive Culture & Environment
