Part III: Planning for Improvement

Data Analysis

Answer the following analysis questions using the progress monitoring data and state assessment data, if applicable.

What trends emerge across grade levels, subgroups and core content areas?

Students within the SWD subcategory show a trend of an increase in points over the past three years within ELA Achievement, Math LG, and Math LG L25%. Within all student subcategories, the greatest point increase trend is within the Math LG L25% most significantly reflected within the subcategory of FRL with a 30 point increase compared to 2019.

6th-8th grade students have not yet achieved the same level of proficiency percentage in ELA as compared to the 2019 results. However, the 6th and 7th grade students continue to close the gap from the 2021 decline with a 6 point and 8 point increase respectively.

8th Gr math and science surpassed 2019 scores with a 23 point increase in math from a 33% to 56% and in science from a 27% to 31%. 8th gr math with a performance of 56%, out performed both the district and the state in 2022 with a 17 point performance above the district at 39 and a 14 point performance above the state at 42. In 2019 and 2022, the middle school Algebra I cohort exceeded the district and the state. In 2019, the middle school Algebra I students scored at 75% with the district and state performance of 63% and 61% reflectively. In 2022, with a comparative performance of a 14 point and 17 point performance over the district performance of 57% and the state 54%.

What data components, based off progress monitoring and 2022 state assessments, demonstrate the greatest need for improvement?

Based off progress monitoring and the 2022 state assessments, the greatest need for improvement lie within the core content area of ELA which influences the student performance in all content areas especially in science and social studies. This is also reflected in all subcategory of students, with the exception of SWD ELA Ach, where students have not yet achieved the same performance level as in 2019.

In addition, more focus needs to be given to the middle school acceleration score component as this area has taken a 35 point deficit compared to 2019 and continues to trend below both the district and state.

What were the contributing factors to this need for improvement? What new actions would need to be taken to address this need for improvement?

Factors contributing to this need of improvement include the pandemic guidelines, transitioning students back to a traditional school setting, lack of student motivation, lack of consistent student attendance, lack of qualified teachers available for hire, and the loss of the ELA/Reading Instructional Coach. To address this need for improvement, an incentive program to increase student motivation is to be put into place, increase marketing to attract qualified teachers, detailed monitoring and increase parent communication concerning student attendance, and grow leadership within the school to place an ELA/Reading Instructional Coach.

Identifying students in 6th grade with indicators such as state assessment performance or identified as Gifted, and place them in accelerated subject areas to build capacity and cohort size for the future 7th and 8th gr accelerated classes like Algebra I, Geometry, and Biology.

What data components, based off progress monitoring and 2022 state assessments, showed the most improvement?

ELA and Math learning gains and L25% performance increased comparing 2022 to 2019 assessment results. The greatest increase in these categories is found in math with an increase of 16 points in learning gains and 27 points in the L25 school grade components. This is also reflected in student subcategories of ELL, HSP, and FRL.

What were the contributing factors to this improvement? What new actions did your school take in this area?

The contributing factors to this improvement include, refinement of lesson plan development, deeper dive into student data, consistent implementation of ESOL strategies within all core content areas, development of instructional focus calendar specific to standards for RtI, push in intervention, incentive program for student performance on SuccessMaker, and afterschool tutoring.

What strategies will need to be implemented in order to accelerate learning?

Strategies that will need to be implemented in order to accelerate learning include increase rigor in the classroom through PBL and cross curricular instruction, increasing DOK of higher order thinking questions used to probe and check for student understanding, align lesson plan development to level 3-5 of ALD's as it pertains to the lesson standard, and implement strategies to fill in gaps from missing skills with the new BEST Standards.

Based on the contributing factors and strategies identified to accelerate learning, describe the professional development opportunities that will be provided at the school to support teachers and leaders.

The professional development opportunities that will be provided at the school to support teachers and leaders include in depth training on the intensive reading curriculum iLit45 and available reports and Math curriculum and reports available through SuccessMaker with the implementation of the new BEST Standards and infuse STEAM into the classrooms to promote PBL and cross curricular instruction to increase depth of knowledge and critical thinking skills.

To ensure sustainability of improvement, additional services that will be implemented include continuous communication with all stakeholders of current data trends throughout progress monitoring, after school tutoring, and mental health support.
