Section 1001.42(18), Florida Statutes (F.S.), requires district school boards to annually approve and require implementation of a new, amended, or continuation SIP for each school in the district which has a school grade of D or F; has a significant gap in achievement on statewide, standardized assessments administered pursuant to s. 1008.22 by one or more student subgroups, as defined in the federal Elementary and Secondary Education Act (ESEA), 20 U.S.C. s. 6311(b)(2)(C)(v)(II); has not significantly increased the percentage of students passing statewide, standardized assessments; has not significantly increased the percentage of students demonstrating Learning Gains, as defined in s. 1008.34, and as calculated under s. 1008.34(3)(b), who passed statewide, standardized assessments; has been identified as requiring instructional supports under the Reading Achievement Initiative for Scholastic Excellence (RAISE) program established in s. 1008.365; or has significantly lower graduation rates for a subgroup when compared to the state's graduation rate. Rule 6A-1.098813, Florida Administrative Code (F.A.C.), requires district school boards to approve a SIP for each Department of Juvenile Justice (DJJ) school in the district rated as Unsatisfactory.

Additional Target Support and Improvement (ATSI)

The lowest performance area was ELA (21% proficiency). Contributing factors to low student performance include instructional vacancies, new grade level benchmarks, and deficiencies in foundational skills.

Which data component showed the greatest decline from the prior year? Explain the factor(s) that contributed to this decline.

Science proficiency showed the greatest decline from the previous year. In 2021-2022, the percent of students proficient in science was 29%. In 2022-2023, the percent of students proficient in science was 18%, a decrease of 11%. Contributing factors to low student performance include instructional vacancies, new grade level benchmarks, and deficiencies in foundational skills.

Which data component had the greatest gap when compared to the state average? Explain the factor(s) that contributed to this gap and any trends.

4th grade ELA and Math had the greatest gap when compared to the state proficiency average. In ELA, the state's proficiency was 57% and our school's proficiency was 20%. In math, the state's proficiency was 61% and our school's proficiency was 29%.

There was no improvement made. There was a decline across all content areas (ELA, Math, and Science) as compared to previous years.

K-2 students will be assessed at the start of the school year using baseline assessments, and student data will be analyzed on PLCs to ensure students receive targeted interventions based on needs through the MTSS process. Foundational skills lesson will be implemented within the ELA block using UFLI curriculum to ensure student learning gaps are targeted early. Additionally, students will use personalized iReady Reading lessons to provide additional targeted intervention supports. Student date will be tracked within PLC data chats to ensure student academic needs are met.

Grades 3-5: Instructional Practice specifically related to Reading/ELA

Student date will be tracked within PLC data chats to ensure student academic needs are met.
