School Board Approval

This plan was approved by the Lee County School Board on 10/17/2023.

SIP Authority

Section 1001.42(18), Florida Statutes (F.S.), requires district school boards to annually approve and require implementation of a new, amended, or continuation SIP for each school in the district which has a school grade of D or F; has a significant gap in achievement on statewide, standardized assessments administered pursuant to s. 1008.22 by one or more student subgroups, as defined in the federal Elementary and Secondary Education Act (ESEA), 20 U.S.C. s. 6311(b)(2)(C)(v)(II); has not significantly increased the percentage of students passing statewide, standardized assessments; has not significantly increased the percentage of students demonstrating Learning Gains, as defined in s. 1008.34, and as calculated under s. 1008.34(3)(b), who passed statewide, standardized assessments; has been identified as requiring instructional supports under the Reading Achievement Initiative for Scholastic Excellence (RAISE) program established in s. 1008.365; or has significantly lower graduation rates for a subgroup when compared to the state's graduation rate. Rule 6A-1.098813, Florida Administrative Code (F.A.C.), requires district school boards to approve a SIP for each Department of Juvenile Justice (DJJ) school in the district rated as Unsatisfactory.

Additional Target Support and Improvement (ATSI)

Academic growth continues to be a concern for our student population and the greatest need for our students. Although data was incomplete, results monitored throughout the school year indicate that the transient nature of our students negatively affected students progress toward grade level standards.

Which data component showed the most improvement? What new actions did your school take in this area?

Data collected from the previous years was incomplete. The number of students making gains is not available and the credits earned is also not accessible to the teachers. Although data is not available from the previous year, the data collected within the district demonstrates that implementing formative assessments regularly, instruction that is aligned to our District academic plans along with scaffolding of instruction allows for students to transition back to the home schools with a reduced gap in educational time.

Reflecting on the EWS data from Part I, identify one or two potential areas of concern.

Data collected from the previous years was incomplete. The number of students making gains is not available and the credits earned is also not accessible to the teachers. Focus is student's daily attendance. Rationale is that in the past the students have been removed from education thus missing time in the classroom. The majority of students enrolled in the Detention Center are below grade level for Math. The majority of students enrolling in Detention Center are reading 2 or more grade levels below their cohort.
