### **Purpose and Outline of the SIP**

The SIP is intended to be the primary artifact used by every school with stakeholders to review data, set goals, create an action plan and monitor progress. A corollary at the district level is the District Improvement and Assistance Plan (DIAP), designed to help district leadership make the necessary connections between school and district goals in order to align resources. The staff and faculty of Upthegrove Elementary School will provide a wide range of learning opportunities for all students, staff and faculty. Class sizes will be maintained per state and local guidelines. Quality education will be on the cutting edge and current to state guidelines. All students will be expected to achieve their fullest potential by attending and participating to their best ability. Parents and community will be expected to be involved with the school. All available resources will be used to accomplish these goals, including county, school, community and other state agencies.

#### **School Environment**

# Describe the process by which the school learns about students' cultures and builds relationships between teachers and students

Edward A. Upthegrove teachers and staff strive to build positive relationships with all students. We incorporate celebrations of different cultures, ie. Cinco De Mayo within individual grade levels as well as Christmas Around the World activities to learn about the different cultures. We are also incorporating our AR theme school-wide. which encompasses the theme "All Around the World". Our AR/AM reading/math program allows for individual student progress with teacher/student conferences occurring often with reviews on status of student work and understanding of content. Utilizing the Successmaker program in the reading and math content area, allows for students and teachers to work together in constructing graphs to show progress. We have adapted time within the day for consistent feedback with students on their academic progress.

# Describe how the school creates an environment where students feel safe and respected before, during and after school

Students are greeted when getting off the bus or at the pick-pick-up line. Students are monitored while sitting on the benches outside of their classrooms or at breakfast and allowed in the classroom at 7:55. Students are also monitored in the afternoon whether at buses or parent-pickup. When students are not picked up by 3:00, a parent/guardian is required to sign them out of the office. Edward A. Upthegrove SIP team has reviewed and made changes within our school compact to incorporate a more wide range of guiding questions on expectations of all participants We have expanded our agreement to include: paraprofessionals as well as custodial, office staff, etc. Additional statements include: For students; I agree to treat other students and adults with respect. For parents: no changes made.

Included within the teacher section: added Paraprofessional/staff as well as the added statement: I agree to treat all professionals, staff, parents and students with respect.

Describe the schoolwide behavioral system in place that aids in minimizing distractions to keep students engaged during instructional time. This may include, but is not limited to, established protocols for disciplinary incidents, clear behavioral expectations, and training for school personnel to ensure the system is fairly and consistently enforced

This past summer, Upthegrove Elementary school made available to all staff a training on Positive Behavior Support so that our school, could incorporate this program school wide. It was well received and new behavioral policies have been put into place. PBS is the application of evidence based strategies and systems to assist schools to increase academic performance, increase safety, decrease problem behavior and establish positive school cultures. For example, these policies allow for students to spend more time in the classroom with fewer distractions and gives teachers more specific guidelines and tips for handling varying types of behaviors prior to getting to the level of being sent to the office. This new program sets up more positive communication with parents/students/ school leading to success for all.

Parent communication and keeping in touch with our students' needs is a vital part of making sure that students needs are being met. Our Counselor, Dean, and Principal all have an open door policy to which parents, as well as students, are encouraged to stop by if needed. We are in the beginning stages of working with the Big-Brother, Big Sister program brought to our county this year to help mentor our students who quality.

We also have outside counselors that provide services for students on a weekly/monthly basis.

1st grade attends the local Barron Library to learn about checking out books for summer reading.

2-5 grade attends the Caloosa Nature walk which provides a wide range of learning experiences after a week long of preparing for Earth Day celebrations.

The team will assist teachers in the processes of MTSS. Professional Development activities relative to the MTSS process used in the identification of eligibility for ESE services, and assisting in identifying relevant interventions and demonstrating proper data collection techniques. The team will ensure that the school is providing high quality instruction and interventions are matched to the needs of the individual student. The team will also ensure the use of learning rate over time and level of performance to make important educational decisions to guide instruction.

Title 1 Part A/Part C - Parent Involvement strategies will be included within SAC and the \$ attached to our School Advisory Council. Some funding from SAC include money set aside for our Family Reading Night as well as our Fall Festival and the Wild Wizard on campus field trip. These are not set out to be a fundraiser but an outreach to get families involved in their child's education. We also provide parents with translators on nights of parent conferences, open house, travel to school for meetings when necessary.

The Homeless Program helps our students with Backpacks, supplies. etc. Also, Community Organizations have put together a food backpack ministry to help many student (many homeless) on weekends to have food available to them.

Our Title III program assists our school with the transition between the RCMA/VPK programs. We will coordinate with this program through a program called Block Fest which will assist parents and children with the transition from VPK to the public school setting. The Title I Director will coordinate with the VPK Program Directors to set up this event.

UES will use the DARE program at the beginning of the school year to assist students with making the right choices when coming across with PEER pressures. This program is only one of Violence Prevention used at UES. The new Prevent Bullying Curriculum coming from the District level will also be taught at UES through the Guidance/Admin offices.

The major initiative of the RLT will be in monitoring the success the of our current literacy programs: STAR, STAR EL, EL, AR, Successmaker, as well including the current District reading curriculum. Grade levels will share goals and usage of current literacy programs in order to ensure these programs are being utilized for high quality instruction and data collection. PLCs will be continued to focus on incorporating Differentiated Instruction (DI) into daily classroom activities. Team members will evaluate and monitor the progress of implementation on a monthly basis. Professional articles and texts will be utilized to assist in this process.

# Describe the school's strategies to encourage positive working relationships between teachers, including collaborative planning and instruction

Teachers at UES will be given opportunities to plan collaboratively not only within their grade level teams but as well, their small group teams which include: resource, ESE and reading coach.

Small group reading instruction occurs daily and is a 30 minute block of time where groups have been dividing working on specific ability levels and then working with particular areas of difficulty for those groups of students.

Data meetings are held monthly with the grade levels, Reading Coach, Reading, Resource, Guidance, Dean/Principal. At these meetings, we review data, help to discuss what is working within the groups, what needs to be adjusted and review the student groups themselves as some students should consistently be moving within the groups after these monthly meetings.

# Describe the school's strategies to recruit, develop and retain highly qualified, certified-in-field, effective teachers to the school

Once highly qualified teachers are hired, Edward A. Upthegrove Elementary provides many opportunities for new teachers to learn from highly qualified veteran teachers on staff. These opportunities include the option to visit other classrooms where they will see instructional modeling by veteran teachers. They

work closely with a mentor teacher. Each mentor teacher has successfully completed the Clinical Education endorsement.

Administrators in Hendry County are encouraged to attend local and state recruiting fairs that are held in April of each school year. The principals work closely with the Human Resources office to obtain applicant information that reflects the highly qualified status that they are looking for to fill their open positions. Principals also views the Heartland Consortsium Applitract website to assist in locating highly qualified candidates.

Monitoring Plan includes: Weekly meetings to discuss issues of importance. Mini workshops in various areas of professional development such as Write Traits, Differientiated Instruction, Common Core, Lesson Planning and understanding data

New teachers needing mentors include: Mrs. Chassey and Mrs. Davis. Mrs. Tack will be their mentor. She has taught pre-kindergarten - 4th grade including ESE, for 10 years and is our Reading Coach. She is the Lead Teacher for 1 and 2nd Grade. Mrs. Tack is experienced in Differentiated Instruction as well as the new Common Core Curriculum.

### Describe how the school ensures its core instructional programs and materials are aligned to Florida's standards

New reading and math textbooks were purchased last year for K-2 that are specifically aligned to the new Florida Standards. This current school year 3- 5 was added to the new curriculum to meet these new standards.

Our Reading Coach and Reading resource teacher are continuously looking for additional resources that relate to these new standards and sharing them with the staff through professional development and small group settings.

UES has implemented small groups within grade levels to assist students experiencing difficulty with varying skill areas. Data meetings are held monthly to assess student progress and adjust groups as needed.

Working within these flexible small group settings will help students attain the proficient or advanced level on state assessment.

#### Strategy: After School Program

#### Minutes added to school year:

UES offers a Migrant After school program that assists students with homework help. A Language Acquistion after school program is also offered 2 days a week after school. These programs will begin sometime in October 2014.

UES also offers Computer Lab time in the morning using the Successmaker Program for students in 2nd - 5th grade needing additional assistance in preparing for the statewide assessment test.

#### Strategy Rationale

The morning lab and after school programs that we offer assist students with individual help in areas of difficulty for them and are tracked continuously using data such as grades, SM reports, and/or conferences with teachers.

The Migrant After school program is strictly used to assist students with homework and then offer additional resources to enhance appropriate grade level academic needs. The effectiveness of this program is directly seen within the individual student's classroom and has direct impact on his student achievement. Improvement is seen within the students report card as well as discussed, if needed at parent/teacher conferences.

The Language Acquisition Program is used to assist student having difficulty with the English Language and is not given a pre/post test. The effectiveness of this program is directly seen within the individual student's classroom and has direct impact on his student achievement. The students who attend the morning lab will be tracked by their classroom teacher on their progress and will assist the teacher in making adjustments to the DI they do in their classrooms.

UES has one migrant VPK program. Out teacher implements phonemic awareness, alphabet recognition, phonics, concept of print, read alouds, number concepts to 20, fine and gross motor skills, and learning centers in her lesson plans. Listening and folling directions is also an important component in her lessons.

At UES, all incoming Kindergarten students are assessed upon entering Kindergarten in order to determine individual as well as group needs. Students are assessed based on school readiness, oral language, print/letter awareness, phonemic and phonetic awareness.

Screening data will be collected and analyzed by classroom teachers and resource teacher in order

to provide targeted instruction based on individual needs. The tools used to collect date include: FAIR, FLKRS and Discovery Ed.

UES offers a visitation day for headstart and preschool students who will be attending our school. The pre-schoolers receive a tour of the school and are included in the activities within the kindergarten classrooms for that day.

Students going to the middle school have a pre-planned visit prior to the end of the school year to the school site. A presentation on what is expected and a tour is given at this time. The Middle school also has an open house prior to the school year starting for all new incoming students. 5th grade ESE students are given a transition packet at their IEP meetings.
